# **SPECIAL ORDER OF BUSINESS**

#### Census 2020

Kienlen relayed that she, Wells, Gustine and Massias have applied for a grant to get information out there regarding the Census. The grant will be applied to work on fraud, billboards, home-bound seniors with no computers, etc. There will be sites set up to help seniors complete them, such as at the Senior Center locations and the library. Molvang inquired whether there would be help for some of the support groups. Ascione- Blakey relayed she could compile a list of the support groups. Carruthers inquired whether COA in-home health care employees could possibly help with that.

# Proposal to reclassify field staff

Kienlen mentioned this at the last meeting. COA is working to reclassify some of the field staff. Kienlen passed out a marked up a copy of the job classification for Home Health Care (HHC) to the members. Kienlen relayed that this would also raise the Homemaker Aide (HMA), Home Chore (HC), as well as the HHC workers up a level. She is currently working on the job classifications for the HMA and HC workers. She noted that there are many things that staff are doing which is not included in the job descriptions. There are 16 (Universal Aides) UAs and 8 HMAs. HMA and HC workers would go to pay scale C level, HHC would go to D. Discussion on the difficulty in keeping employees at the amount of pay being offered. Discussion on wound care, employee turnover, assistance in maintaining a healthy environment, and clients meeting nursing home criteria.

Approval of the job descriptions/reclassification for Universal Aide, and upgrading Home Chore and Homemaker Aide workers.
